With a strong vision of our future in place, we are prepared for growth, discovery and service.

Construction was completed July 2021, almost one year after we broke ground on the new Regional Skill Center and Chinook Residential Hall. This past fall we welcomed student to live and learn in these two new buildings. This represent the largest expansion of the college's physical capacity since 2008.

The Regional Skill Center is the first CTE educational facilities in the Columbia Gorge dedicated to offering accessible education to thousands of under-recourse students. With rising housing, transportation, human health care cost, and other unemployment and economic impacts, it is becoming increasingly difficult for families in our community to earn a livable wage.
